ATTENTION - New Schedule of Trials

All classes will run in consecutive order with no set start times for any classes except the first of the day.

Ring 1 - Senior Tr. 1 and Senior Tr. 2. To be followed by Instinct Tr. 1 - Novice Tr. 1 - Novice Tr. 2 - Open Tr 1 and Open Tr. 2

Ring 2 - CRAZY 8s Tr. 1 and CRAZY 8s Tr. 2 to be followed by Master Tr. 1 - Master Tr. 2

Ring 1 & Ring 2 -Sunday Classes, Trials 3 & 4, will be the same as Saturday's Schedule
